Our Strategic Plan

YEAR 1-2 TACTICAL PLAN

Promote Bampa's House - its mission, values and goals in Chemung County & the surrounding area - by building awareness, recruiting community involvement and fund development assistance where possible. In doing so, the Chemung County Comfort Care Committee will complement, not compete, with Bampa's House services.

Host the Bampa's Annual Golf Tournament at Elmira Country Club on September 27, 2021 with a goal of raising \$15,000 in the first year.

YEAR 3 TACTICAL PLAN

With Bampa's House, our committee will reassess the demand for comfort care in the tri-county region. We will **continue vital fundraising efforts in Chemung County** to support Bampa's House.







YEAR 5 TACTICAL PLAN

We will continue our close collaboration with Bampa's House, formulating a plan based on Year 3 demand analysis. We will potentially team or partner with an established provider of similar services in Chemung County. Above all, future regional expansion will be pursued based on need.

Facts and Figures

- ✓ According to the US Census Bureau, there are 17,249 Chemung County residents aged 65+
- ✓ Since opening its doors in September 2020, **50% of Bampa's House residents have come from Chemung County.** 42% of residents were from Steuben County, with the remaining 8% from other counties in the Southern Tier
- ✓ A mix of very few staff members and over 80 volunteers provide **24/7 care and support** to families who come to Bampa's House
- ✓ Operational costs of providing this irreplaceable service exceed \$200,000 per year, which is **fully funded by community donations and fundraisers**
- ✓ Fundraising events, grants, and an annual direct mail appeal led by the team of Dugan family members and close friends have **raised over \$750,000 to purchase, renovate and retrofit the home to date.** The Chemung County Comfort Care Committee is committed to assisting the family in these efforts.

Did You Know?

Located in Corning. Bampa's House welcomes no more than two Southern Tier residents at a time, who wish to spend their final weeks in a home like setting, free of charge.



Admission eligibility includes having a terminal diagnosis, an inability to be cared for in one's own home, and a desire not to die in an institutional setting, such as a nursing home or hospital.

During their stay, families are encouraged to share in the living experience, with full access to living quarters, office space, and an ADA compliant kitchen.

Each resident room includes a private outdoor deck, so that lasting memories can be made inside and out. Classic Victorian architecture enhances the living experience, making it truly feel like home.

Services are of the highest possible quality, delivered personally and equitably, to ease individuals from this world with care, while also easing the anxieties and challenges of the dying person's loved ones, the most challenging work of all.
